Mr. Pickup,

Your rhetoric and delay in writing violations is unacceptable. Protocol for the "regulatory review" you speak of should include the issuance of violations. If Rye is not willing to play the part of Health Department, why weren't violation issued and Kuder Island referred to the Health Department for approval in writing before the city releases the violation and imposes fines?

Your "reasonable solution" to your "regulatory review" is just another way to delay and avoid compliance on Hen island. If the end result is really to fix the problems, as the complainant why wasn't I allowed to attend the meetings or at least be supplied with minutes and a list of attendees of the meetings? If someone is breaking the laws in Rye are they issued a violation or arrested or are they asked to come in for a meeting to discuss the laws they broke.

A few months ago, I was issued a violation for speeding on Post Road. Can you tell me why I had to appear in front of the judge and pay a fine and why I was not called in for a meeting instead? Your statement referencing litigation of the mosquito infestation on Hen Island is again incorrect. Are you aware that the Supreme Court issued a Temporary Restraining Order (TRO) compelling Kuder island to implement a mosquito control program in 2007?

Your references to composting toilet standards are also misleading. If you read the code you would see by the supplied chart that the systems in question require separation distances between components and wetlands or watercourses of between 25 to 100 feet. Hen Island in its entirety is a wetland. If the state standards do not allow working systems near the water, why is Rye allowing systems that are not working and installed illegally to be less than ten feet from the water?

Speaking on potable water, are you trying to lead anyone to believe that collecting bird feces infected water from rooftops will now be permitted according to the new code? Lastly the certified results and tests that you state are not available can be viewed at the below attached link. Mapping included showing the proximity opposite the Greenhaven Homeowners Association Beach.

Ray:

The complaint that you forwarded in March has been moving through a thorough regulatory review, and I am confident that the efforts of the Health Department, the Kuder Island Homeowner's Group and the City will come to a reasonable solution.

The mosquito issue has been litigated and reviewed, and the City is comfortable in our position that we discussed at Council at the April 15th meeting. The 2010 updates were effective February 3, 2010 state of New York title 10, Department of Health, Chapter II, Part 75 (section 75-A.1-75 A.11) The composting toilet standards are NSF/ANSI certified. The definitions for potable water are from the 201 residential Code of New York Sate (Chapter 2 Definitions) page 13.

The issue you raise in your April 23rd concerning sewers polluting waters off of the Greenhaven beach is not certified with any results that the City or County or Long Island Sound Study Watershed publications can verify. If you have specific data the City would be happy to include this in our regulatory review.

Scott, I was disappointed with your response as I was hoping that this would be a transparent event with the City. I did have a phone conversation with Mr. Mooney after I received your e-mail and although I did speak to him about the meeting, I am interested in the City of Rye's take on the meetings and what has and will transpire as a result of those meetings on the part of the City. Although Mr. Mooney did call, he only spoke of the County's position and raised his own concerns as to how Rye and Kuder Island Colony would respond. He did however make reference to the Judge's decision stating that Rye presently has effective codes to deal with the issues in question.

Your letter to Mr. Ninivaggi suggests that remediation of the Mosquito infestation is a responsibility of the City of Rye or the county of Westchester. I don't believe this is true according to Rye's code sited below; 108-40 Grounds, buildings and structures shall be maintained free of insect, vermin and rodent harborage and infestation. Methods used for exterminating insects, vermin and rodents shall conform to generally accepted practice. 108-43 Owners of premises shall be responsible for compliance with this chapter and shall remain responsible therefor regardless of the fact that this chapter may also place certain responsibilities on operators and occupants and regardless of any agreements between owners and operators or occupants as to which party shall assume such responsibility.

Additionally the letter you included from George Vaselekos has nothing to do with the situation on Hen Island as we have no catch basins to be treated. I asked you and I will ask once again if you could please "provide me with dates of the meeting referred to in your e-mail response, along with any letters, minutes, notes, a list of those in attendance and any communications with regard to that meeting? Could you also provide the same with regard any prior or subsequent meetings with either Kuder Island Colony Inc. or Westchester County?" If necessary I will be happy to FOIL them but I was hoping that would not be necessary. Finally I would ask once again that I be included in all the correspondence, meetings and inspections. Scott, I am not looking to play games just looking to put this long avoided problem behind us once and for all. I am not concerned about who made mistakes in the past. I was hoping that this time around everyone was going to be honest, up front and would just address the problem. Should you like to continue as we have in the past, I will be happy to do so but I was hoping that would not be necessary for either one of us?

Please Scott, lets all just sit at the same table and work together so we can move on.
